1. Introduction

Trustwave Holdings, Inc. and its subsidiaries ("**Trustwave**") are absolutely committed to our practices to combat slavery and human trafficking in our business and supply chain.

In accordance with Section 54 of the Modern Slavery Act 2015, this statement sets out Trustwave's position and its actions in the past financial year to ensure slavery and human trafficking do not take place in our business and any party of our supply chains.

2. Our organisational structure and services

Trustwave is a services provider in the cybersecurity sector. We are wholly owned by MC2 Titanium LLC, which is a subsidiary of the ultimate parent company, The Chertoff Group LLC. We have approximately 1,000 employees worldwide and operate in the following countries: Australia, Belgium, Canada, Colombia, Germany, India, Japan, Mexico, New Zealand, Philippines, Poland, Singapore, South Africa, the United Kingdom, and the United States of America.

3. Our supply chain

Trustwave also maintains an independent internal audit function which performs risk-based audits on policy management and compliance activities.

5. Due diligence

Trustwave undertakes due diligence when considering new suppliers and regularly revaluates existing suppliers, Trustwave's due diligence activities include:

- creating a risk profile for each supplier
- verification and review of purchase terms
- running trade compliance and modern slavery checks on each supplier as needed
